RESULTS OF THE SURVEY CARRIED OUT IN

MARCH 2015

The survey was delivered to every household in the parish, local organisations and known businesses. Additional surveys were available from the local shop, public house and the community centre. Exhibitions were held on 12th March 2015, 13th March 2015 and at the Annual Parish meeting on 16th March 2015.

This was also advertised in the parish noticeboards, the St Erme Village Voice, the local Post Office/Stores, public house, community buildings and on the council's website.

Residents were invited to give their views on producing a Neighbourhood Plan and to highlight and comment on the areas they wished to be included.

The consultation period ran from 1st March 2015 to 31st March 2015.

2) Should we carry out a neighbourhood plan comments?

- It is very important for local people to have more say in the future of their parish, where they live work and play

- Yes otherwise the time spent on the VDS is effectively wasted
- o If we don't participate we won't have a say in the future of the neighbourhood
- Absolutely

- o Excellent, I'm pleased
- o It is important to make the village fit the true needs in the coming years ahead
- Yes so that we have a say in future developments
- It's important for the village
- o To ensure future development and growth is planned and not forced upon the parish
- Yes so that local people have a say
- o I think it would help protect us from unwanted over development
- o If not any changes whatever will be done without any thought or consultation with people who live here
- o Without a NP our community is vulnerable to inappropriate development. With a NP we have at least some control
- o Too much development would change the village and spoil rural feel of location
- o Without it the parish cannot enforce its will with regards to any aspects of future development
- o Really important that the parish has an adopted plan with specific policies which will help our community grow as we want it to
- o It is vital for future development and sustainability, allowing residents a say in how the village grows
- o Essential for the future of the village
- We need to have a say in any developments in the village

- o The importance of such a plan for the future of any community cannot be over-emphasised and in particular to ours where there is much at stake
- More customers for the Community Centre
- o If it helps to stop 47000 homes being built
- Need to protect our parish
- o Important follow up the VDS
- To improve our village
- o Our community/parish needs could be overruled by Cornwall Council or even National Policies
- To set perimeters over what the majority of the parish need and feel happy with. It gets people thinking what is important for them and their neighbours, in advance of application of potential development.
- o Trispen well located on approach to Truro, but preserve village feel, a now very rare around Truro
- The village/parish needs to control its own destiny in a fair and honest process

- Need to minimise the chance of poor decisions as seen in other areas locally
- More business for local businesses
- essential

- o Our community/parish needs could be overruled by Cornwall Council or even National Policies
- Yes sets boundaries and limitations to potential development. Need to keep what makes our parish special and keep it a place that is desirable to live in.
- o It can lay down the base rules to benefit the community potentially reducing animosity and disputes
- o It allows our parish to decide what is right for the people who live here rather than being told what will happen by outside people
- o Providing planners and developers use it to assist them, It will help the parish steer itself to where it wants to be
- o It would be good if this could bring all local people together, considering what they want or need

6) Housing comments?

- We should be able to choose where and what type of housing a self-building project, and along the lines of what the needs of the community are
- o There will be a need for more housing in the future but if we don't see more council houses being built then who's going to profit???
- Housing that people can afford to rent or buy not the present farce in the system, and not open plan
- Access road to any housing development to be beyond Community Centre, not through the village as already congested. Proportion of starter homes for the over 60's
- e.g. single story or chalet style with ground floor bedroom and bathroom and one room with on suite over as well as a proportion of starter homes for first time buyers and family homes
- o Some to be include for people on a higher income
- Affordable housing
- To control the number of houses put up
- o We would like to see more affordable starter homes to avoid teenager/20's having the leave the village
- o More housing will come. Have a plan for location and pride
- Limited low number only until new roads school are provided
- o Any housing to include bungalows for elderly and very accessible no steps. To retain he balance of the village developments should include low cost housing
- o Make affordable housing for local people, located within appropriate areas this could be discussed
- o I would like to see more housing for local people, if the sewage system can handle it. Housing would need to be located within the appropriate areas
- o Affordable housing for local people, dependant on where it is to be situated
- Not too many houses being built
- For more development purpose only which includes affordable homes for young people who have work in the area NOT for people who purchase second homes, as some second homes in the parish remain neglected and empty
- o More housing could turn Trispen/St Erme into a satellite town of Truro
- Provision for larger housing 4 bedrooms for larger families. All new housing to include renewable energy faculty's e.g. solar panels. Developments must include
 Funding to supplement health services. Development must be controlled and not allowed to spoil the neighbourhood by over development
- o Small developments that will not out do the social status of the village
- o Affordable housing for young people is essential (whether to buy or rent).
- Housing to fit in with the environment and not to obstruct country views
- o Yes the VDS throws up a lot of views on housing, which need to be followed through in the NP
- Need to consider effect another development would have on village. Green space essential
- o To keep our young people in the village but only on any brownfield sites

- Only small (45-55) developments so as not to unbalance the village increasing the size gradually. Affordable housing must be included in every development
- o Limited family housing, affordable for young people to own their own
- o Too much housing I feel would not be necessarily be good for the area
- Any additional housing should be for local people and should be balanced with open spaces and not over development, we don't want the village to lose its community feel
- o We need to control how many and where additional houses go
- o We need retirement bungalow, for elderly and disabled in the parish
- o We have enough houses in parish. But we need retirement bungalows for elderly and disabled
- Restrict private rental market, keep houses free for sale to families
- Local people
- o Housing for families but also for single people and younger people who would like to leave home
- o Individual plots for individual developments to help locals stay within the village
- o It's important for youngsters to have affordable housing opportunities in the village
- o Small individual projects, self-build and character housing should be the focus of any future housing
- o Individual projects and larger houses to accommodate local people so that they can stay in the village
- o Should be affordable housing for local/Cornish only and be at the top end of village and not Truro side, so as to keep the village as it is now
- o We desperately need a better balance of housing, larger family homes are in very short supply (4+ beds) and no retirement home provision that I am aware of
- o We need more larger, family homes and no more affordable housing as we already have enough
- o Any new developments need to be appropriate to the existing infrastructure and facilities with in the village
- The area has reached a suitable size regarding the number of houses it holds and any further expansion ought to be small 'infill' projects or extension of existing houses
- Whilst realising that for profit reasons and no thought to anything else including where houses are built and how many there is a shortage of accessible bungalows for elderly and disabled
- No more high density housing
- We have just had a new development and too many houses would swamp the village
- A critical aspect for any parish. Should include not only totals, total in any single development, style, size, affordable housing and amount of off road parking.
 Also include solar
- Scale/number of houses and location should add character of village and not detract from it. Also a good mix of sizes i.e. 1 & 2 bedroom as well as family homes

- o The expansion of villages and sustainability requires housing, but a plan could help to set planning priorities
- o Do not use viable agricultural land for anything other than agricultural uses. Restrict housing to brownfield sites (if any) and 'infilling'
- We will have to have extra housing but not a huge development such as Trevispen Parc
- o For the benefit of the homeless affordable homes for people to buy
- o Affordable housing for first time buyer
- o No large housing projects as the amenities roads/school etc. not adequate. Smaller developments may be acceptable
- o Some to be included for people on a higher income
- While there is a need for more house-building, both low-cost and open-market, and indeed the scope for it within the parish, the emphasis should be on small developments in suitable locations throughout the parish
- We would need a better mix of size housing, but do enjoy living near various aged neighbours
- Yes it would be nice to meet new neighbours and more customers for the local shop and businesses
- Protect future villagers from wind turbine syndrome by concentrating new housing to the south of the village. This will also protect the views enjoyed by so many to the north
- To restrict open spaces being lost to housing developments
- We need affordable housing and social housing to rent. It would be useful if second homes could pay more council tax to support local infrastructure and amenities
- Should be largely affordable for local people, no second homes?
- o Housing should be affordable for local people to purchase. No second homes
- Selling all the fields off for housing is not right way for the village
- Allotments are needed in village for people with small gardens
- o Too many houses being built in our village
- Affordable 3 bedrooms and above, and flats
- Needed for local people perhaps self-build, 3 bed and above
- o As long as they are affordable and for locals first
- o Any new houses should not be little hutches and have a garden for children
- Local needs, highlighted in VDS to be delivered
- Because more people can live there
- Won't be able to avoid new housing
- o Important for communities to expand but sets limits to local demand. Sets boundaries for good area to development vs more difficult sites. Keeps our amenities and benefits. New Wainhomes do we need more? Need good design in keeping with cottages around Trispen.

- o Housing is emotive and there are only a few minor sites suitable for its location. Better quality of design/layout is required to improve the community.
- Housing needs a limit boundaries have to be sensible
- o It should be based on the need for an affordable housing stock, both owner occupied and rental
- o Needs to be planned carefully with extended services to support any further housing developments
- o Would li like to see guidance on: development size, housing provision, design/architectural style, housing/amenity
- We need to have some say in proposal planning applications
- o Providing roads, schools adequate to cope with small amount of residential buildings
- o What do local people really need how many bedrooms/bungalows for disabled
- Village needs low cost housing
- We need more affordable housing
- o Individual or small new housing
- Yes providing everyone agrees where new housing goes in the parish
- o Housing needed but careful and informed choices should be made as to where, when, how and type
- No way of avoiding it

8) Business comments?

- o Small scale business is important for the sustainability of any community, possible work from home opportunities
- I would like to see the pub protected from future demolition!! (It's happened elsewhere)
- No shopping developments or factories, small business from home would be ok
- Truro provides these
- o Again important to provide and retain work in the local community
- o But I don't see real opportunities
- Small business only
- Small business opportunities for locals no major industrial development as this is essentially a agricultural village
- Only if local people want to run their own business and employ local people were able to benefit and to exclude industrial. Concerns that would destroy
 the village life of the area
- Butchers shop. Fishmonger
- o Small developments that will benefit the folks who live in the village
- So people can work in the village
- o Local part time and full time vacancies to be advertised locally and on-line. Any opportunities would be welcome, also for the over 50's and 60's group
- o Possibly, although I think the scope is much more limited
- Yes to keep the village alive
- o Yes for local development opportunities for small businesses, no large industrials
- o More facilities. Not enough for size of village Launderette, Chinese restaurant
- o There are adequate local opportunities without more business in the immediate area
- o There are plenty of employment opportunities within easy commute. This is a village not an industrial estate and that is how I like it
- o Bigger shops / more shops local employment. Threemilestone is a good example of village
- o Would like to see rural workshops maybe small units and to protect our small farms and smallholdings
- o It would be good to have more business opportunity/employment closer to home
- o Homework and small business units may allow parishioners the opportunity to work closer to home
- o I think so, but supply and demand needs to dictate this too some extent
- o There a number of people in our parish that run business from their own houses and so small non industrial units would be useful
- We are very close to the city of Truro, already have a great shop, school and public house
- o Possibility of providing small scale industrial units to allow local businesses into the village/parish
- o Set out where business units could go

- This is an area lacking in the parish and yes this is vital for sustainability and local economy
- o Industrial units could be a good idea but where would they be sited bearing in mind comments made to question 5
- o There has to be something to keep young people in the village
- For the use of local people with small business projects
- o No big shopping developments or factories / small business from home would be ok
- o I did once prepare and submit a draft for a Building and Associated Trades Cooperative within the parish.
- o Our youngsters need more opportunity to work and stay here
- A better shop that opens a later time and more facilities for the local community
- No large industrial business but perhaps develop a small, low level area of workshops and offices to give opportunities to current home workers or start up business by villagers
- Another shop longer opening
- o Small business possible
- More smaller businesses like a shop
- Already have a successful shop, a pub, garage, farms, accommodation providers and many internet business
- o Creates jobs and sustainable income for families potential in Trispen
- Small (perhaps niche) business parks/developments are important. The village/parish is well located and should be attractive to investors. Location is key
 to benefit the community
- Focused and small rural businesses
- o This is the future for our children and for the continued prospering of the village
- St Erme Parish location has much more potential for business excellent transport links especially a business plan to encourage organisations to the area would be ideal
- o Small units for village businesses presently working from home may be useful
- Small local businesses would be acceptable
- Small businesses are more appropriate to the village
- Small businesses for local people
- o This parish needs small workshops for local people to run their own enterprises
- Small individual???? Industrial units
- Yes if all agree
- o Moving forward as a community we should be open to new business ideas and opportunities then make an informal decision

10) Leisure & Community comments?

- Second and third phases should be looked at for the community centre, possible skate park in the school playing field, other uses for the village hall

- Important to offer local facilities to avoid the need to travel and to retain local identity

- Add to existing facilities
- A further expansion to the existing facilities to provide indoor sports area would benefit all
- o Help St Erme Village Hall to finish refurbishment and up keep so that the people of St Erme have easy access to leisure facilities
- More activities so that children have more available
- We need additional car parking in addition to that available near community centre. E.g. Any new development along Chapel Road to include Public Parking
- which would provide access to shop/chapel
- Only add to the facilities that we already have
- o Fitness suite in village
- The new community centre is an asset and obviously well used by many local groups. Activities at the new centre need to be well advertised within the village.
- o What about an annual community walk? Xmas or New Year? O a community summer picnic
- I don't think this should be a focus area of the NP
- To expand on the present facilities only
- o Existing facilities extended only A sports hall for the Community Centre and support to upgrade the kitchen and toilets at the village hall
- More sporting activities for the young
- o Community Hall is great, But not enough is done for teenagers
- O There should be more leisure facilities for the older members of the community. It's not all about the youngsters
- o Community centre to include leisure facilities, better access to the public. Expansion is essential
- The only way forward is for the community centre to be better supported perhaps the village hall and centre could merge under an umbrella committee for future survival

- Facilities for the youth of the village (partially teenagers)

- Consideration of school extension if more houses built, possibly evening classes at the school
- o Adult learning in the day time and evening
- More activities for older people in St Erme
- Not sure this is a priority given facilities elsewhere
- School extension if more housing is built
- The primary school has a good reputation which is excellent. Adult learning opportunities need to be well advertised. We could do with more adult groups
 that are affordable
- Very limited scope
- o For those that can't get to Truro essential
- Not bothered majority decision
- Education for young people I.e. evening classes sport
- o We have an excellent primary school, nursery facilities and Truro City offers all the adult education needed
