Public Defibrillator

The defibrillator is now ready for use if required on the outside wall of Trispen Stores.

Anyone can use this, you do not require any training, the defibrillator will talk you through the process and will not shock anyone that does not need it.

However as part of our British Heart Foundation grant we have been asked to hold CPR training with a kit supplied by them and at the same time we can show a DVD on how to use the defibrillator. Please look out for dates and book a place.

Open Space Monies and Community Benefit Monies

Following on from the open space consultation we have received quotations from the top three suppliers chosen by the community and have now agreed the new play equipment.

There will be outside Gym equipment for the Football Field and further Junior equipment for the School Playing Field (subject to a new lease agreement with Cornwall Council).

We will be looking at installing new seating and picnic benches at the Church Yard, Truthan View, School Playing Field and the Cricket and Football Fields. There will be gates installed at the entrances of the School Playing Field for safety and to hopefully prevent dogs being exercised in this area.

The total cost of this will be £53,880.00

We would also like to order new Toddler equipment for the Cricket Field to complete this project in one go and will be looking at using £1,200.00 from the Community Benefit monies to cover the short fall.

The total costs of the full project will be in the region of £66,000.00 This will be considered at our next meeting on Tuesday 10th January 2017. Please let us know your thoughts on this

BT Telephone Box—Trispen Hill

BT have recently consulted on the removal of the BT Telephone Boxes in the area, the red telephone box at Trispen Hill is one of these. The services at this box were only used twice over the last year, so they therefore feel it is not viable for the future. The options were to remove the box or a local organisation or parish council to adopt it. This has already been done in many areas, and the new uses have ranged from book swops, information centres, defibrillators, plant stalls etc.

As a parish council we have agreed to adopt this telephone box for a sum of £1.00. BT will remove the payphone so it will no longer be in use as a telephone box. Members felt that this old style telephone box is part of the historical scene of Trispen Hill and felt that it was important for it to remain.

Once adopted we will be looking at bringing the box up to a better state of repair.

We would be interested in hearing your views and ideas on its future use.
