Parish Council Elections

On **Thursday 4th May 2017** the 4 yearly Parish and Town Council Elections will be held.

There are 7 seats in St Erme . If there are more people standing than seats in the parish then an election will be held and a statement of persons nominated will be issued on Wednesday 5th April.

If you would like to stand for election and represent your community you will need to complete election papers and return these to Cornwall Council by no later than **4pm on Tuesday 4th April 2017.**

Election packs will be available to be picked up from the Parish Clerk in March (date to be advised see noticeboards).

Public Defibrillator

The defibrillator is now ready for use if required on the outside wall of Trispen Stores. Anyone can use this, you do not require any training, the defibrillator will talk you through the process and will not shock anyone that does not require it.

However as part of our British Heart Foundation grant we have been asked to hold CPR training with a kit supplied by them and at the same time we can show a DVD on how to use the defibrillator. Please look out for dates and book a place.

Highways Issues

The council have been continuing to look at issues relating to the maintenance of the roads around the parish.

We are aware that the rural roads in particular are in a poor state of repair in places with debris on the roads, blocked drains, flooding, potholes etc. Which can cause the roads to be slippery and flooded in places.

Cornwall Council no longer carry out regular maintenance on these roads, like leaf clearance, gully/drain clearing etc. due to budget cuts and concentrate more on the A and B roads.

We have written to Cllr Biscoe (Cornwall Council Portfolio Holder for Highways) regarding the lack of maintenance and safety issues, stating that it will cost them more in the long run, however Cllr Biscoe has replied saying that they do not have the money to carry these works out.

We will continue to try to address areas that are brought to our attention and we ask you to report to Cornwall Council any issues such as flooding, blocked drains, pot holes and debris on the roads and they should come out to clear/inspect them asap.

With regards to the on-going problems of flooding at Tregassow Lane, we are currently in discussions with Cornwall Council and landowners to come up with a scheme to sort the drainage issues and Cllr Eathorne-Gibbons (Cornwall Councillor) is assisting us with this.

Update on the S 106 Monies

We have now agreed the play/gym equipment for areas around the village and are in the process of applying to Cornwall Council for the monies to be released to the parish council. Once this has been received we will be in the position to order the equipment.

The following has been agreed: School Playing Field - Nest swing - junior equipment - picnic bench gates at the entrances of the field. Trispen Football Field -Toddler equipment, outside gym equipment, picnic benches, litterbins Cricket Field - Picnic benches, litterbins St Erme Church Yard —2 seats Truthan View - Picnic Bench and litterbin Trencreek Park - Litterbin
