### The Public House

As our local public house is now closed we would like to provide the community with the following information.

### Community owned pubs?

Over the last 10 years the UK has lost nearly 8000 pubs – around a fifth of all pubs nationally. For many communities, pubs are not just a place to eat and drink; they are central to people's sense of place and identity and they foster belonging and community cohesion.

The David Plunkett Foundation has set up available funding as follows:

THE PLUNKETT FOUNDATION MORE THAN A PUB - Grants and loans packages for community organisations in England that want to take on the ownership of their local pub

The programme offers funding and support to community groups who wish to take ownership of their local pub and who need help to develop their ideas and plans. They specifically wish to work with groups committed to delivering a pub for the benefit of the wider community.

Applicants, who are expected to raise some level of community finance (which will be taken into account when determining the funding mix), and need to meet essential eligibility criteria: There is more information on the following link: https://www.plunkett.co.uk/more-than-a-pub

The programme is open to applications until Sunday 31 March 2019.

# TRURO & ROSELAND COMMUNITY NETWORK AREA (CNA) HIGHWAYS SCHEME

Over the last few years St Erme Parish Council have been looking at ways to inform residents and commuters to slow their speed in the village, especially along School Lane. (the road leading to St Erme with Trispen CP School)

Each year we have been setting monies aside in a reserve budget to put towards an 'Electronic Speed' sign.

During the Neighbourhood Plan (NP) process the steering group carried out a 'Traffic Calming Survey' (a copy of which can be viewed on the councils website on the NP consultation section (<a href="https://www.stermeparishcouncil.org.uk">www.stermeparishcouncil.org.uk</a>).

A few years ago a speed monitor was put in place and the results showed that the majority of residents were within the 30 mph speed limit. It was stated by various agencies that sometimes due to the nature of the road the perception of the speed may look as if vehicles are travelling faster. Due to these results we were not classed as priority in implementing a scheme for this area.

However the safety of parishioner's in St Erme is important to us and we are continuing to work on this.

The NP Survey showed that the majority of parishioners were not in favour of speed cushions, but would like to see a lower speed limit of 20mph within parts of the village and an electronic speed sign along School Lane.

Due to budget cuts Cornwall Council have to prioritise schemes leading to Town & Parish Council's having to take forward the cost of such projects themselves.

As you can imagine this is not cheap and the consultation alone for any highways scheme is in the region of £5,500 even before you add the costs of works to implement schemes.

The new 'CNA Highways Scheme' has commenced this year where each CNA has been allocated a budget of £50,000 for 4 years to spend on highways schemes that fit the relevant criteria.

St Erme Parish Council has registered an 'Expression of Interest' to look at the following areas for St Erme.

**School Lane** (as it's locally known – the road leading to St Erme with Trispen CP School)

- Electronic Speed Sign
- 20mph Speed Limit
- Educational Leaflets/Signage

### **Eglos Road**

20mph Speed Limit

This bid will need to go through several stages and will be considered along with a number of other projects put forward in the Truro & Roseland Community Network Area.

As a council we have allocated £6,000.00 match funding for this scheme.

### **Car Parking**

We are regularly notified of inconsiderate parking in the village.



One of the main concerns is cars being parked on the Emergency Access through Killigrew Gardens, this is classed as a footpath and not a road. It is therefore illegal to park at this location. Further action will be taken on this issue. Please do not park at this location it is for 'Emergency Vehicles' only.

Other examples of inconsiderate parking are blocking or parking too close to garages and driveways, parking on grass verges or pavements or on junctions.

Please also remember that inconsiderate parking can also effect the emergency services attending incidents which could be life threatening. This could effect any one of us.
