Chairman's Report

This year we have had several planning applications none of which have been particularly contentious. There has been community consultations from Legacy Homes who are looking at developing on the land to the south of Eglos Road and we are expecting a planning application to be submitted soon. Downing Ltd carried out a couple of consultation events regarding their proposals for a large scale solar farm on land near to Trewaters and Landrine in Ladock Parish.

We continued our partnership agreements with Cornwall Council to maintain our Public Rights of Way, grass maintenance and street cleansing. We chose to continue our weed treatments and employ an Environmental Enforcement Officer who can issue fixed penalty fines for littering, dog fouling and fly posting.

For several years we have been working towards reducing the speed limits in the village and I am very pleased to say that the works to reduce the speed limit to 20mph in the village and to extend the 30mph further was completed in August. This has been possible with the support from the Truro & Roseland Community Network Highways Scheme who have worked with us on this project. Three further sites for our 'Interactive Speed' sign have been agreed with Cornwall Council which can be used as evidence if any further action is required. We have started the process to set up a Community Speedwatch, this is a national initiative where proactive members of local communities join with the support and supervision of their local police. More volunteers are needed to take this forward, if you are interested in joining, please contact the Clerk.

We have started looking at extending some of the double yellow lines within the village; this will be looked at carefully to make some areas safer, but hopefully not impacting too much on the limited parking there is in some areas. There will be a community consultation during 2023/2024 for these proposals.

The transfer of open space to the north of the Burrington's development to the Council is still ongoing, which is a bit frustrating, but this will hopefully be completed soon.

We have now set up a Climate Adaption Working Group to take forward the Council's Environment Policy. The group have already planted 100 trees in the Parish, children from the local school helped with this and they have been working with the school on other projects too. The Group had a Community Compost scheme which they ran during January which was very well supported and have now set up a Community Garden/Orchard at the Community Centre.

The Ventonteague Wind Turbine along the A30 owned by Cornwall Council will now be granting \pounds 7,500 of Community Benefit to the Parish annually. A Policy is being drawn up on how these monies can be distributed to benefit the Community.

This year we were sad to hear of the passing of Cllr Edwin Riggs, Ed had been a Councillor for 5 years and was keen to get involved and was on many local committees including the St Erme Climate Adaption Group.

The St Erme Community Enhancement Group reformed and organised Queen Elizabeth II Platinum Jubilee events in the village with the help of other local organisations. I would like to thank them for all their hard work in putting together a great weekend of celebrations to mark this event.

In September we were saddened to hear of the passing of Her Majesty Queen Elizabeth II, who had been a constant foundation to our Country and the Commonwealth for over 70 years.

I would like to take this opportunity to thank the members of the Council, Cllr Karen Glasson (Cornwall Councillor), the Clerk and our Environmental Officer for their support, work, and commitment over the year.
