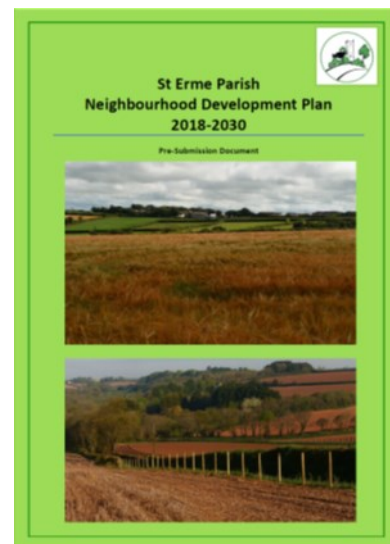

Trees at Trispen Hill

The trees that were planted a few years ago at Trispen Hill have thrived and are developing well. These trees were planted at the advised distances as there would be several that would not take and survive the first few years. This was not the case for us and we only lost a few.

Following advice we have been told that they required thinning out, which has led to quite a few having to be removed and the remaining having their lower branches pruned.

This work has now taken place and the removed trees were offered to local landowners to replant. Cornwall Council had advised us that we could not plant them around the built up areas of the village due to their species and size.

The trees now have room to develop into mature trees as intended.

Car Parking

We are regularly notified of inconsiderate parking in the village.

One of the main concerns is cars being parked on the Emergency Access through Killigrew Gardens, this is classed as a footpath and not a road. It is therefore illegal to park at this location. Further action will be taken on this issue. Please do not park at this location it is for 'Emergency Vehicles' only.

Other examples of inconsiderate parking are blocking or parking too close to garages and driveways, parking on grass verges or pavements or on junctions.

Please also remember that inconsiderate parking can also effect the emergency services attending incidents which could be life threatening. This could effect any one of us.
