Meetings

Due to the Coronavirus restrictions the parish council are unable to meet in public as usual.

The members of the council have therefore delegated authority to the clerk in consultation with the Chairman and Vice-Chairman (or a second member of the council) to take any actions necessary with associated expenditure to protect the interests of the community and ensure council business continuity during the period of the Coronavirus pandemic; informed by consultation with the members of the council.

We have now held our first virtual meeting via Zoom and will look at continuing this during the current government restrictions. As usual the agenda will be displayed 3 clear days before the date of the meeting, which will include information on how members of the public can register to join the meeting.

We do not usually meet during August but if required an extraordinary meeting will be called to consider any planning applications or any urgent business.

These meetings will be held remotely due to Government restrictions and the public and Councillors cannot attend in person, comments and questions the public wish to make on items on the agenda should be emailed to clerk@stermeparishcouncil.org.uk by midday on the date of the meeting or you can register to attend the meeting as stated above.
