The clerk reported on the following:

Damage to the gate at Tower Road into the School Playing Field.

The clerk informed members that since the agenda had been published that it had been reported that the gate is damaged at the School Playing Field and requires repairing as one of the hinges has come away. The clerk has requested a quotation for the work for the gate to be repaired from TMS who installed the gate. It was agreed for the clerk to circulate the quotation for the repairs to be agreed through delegation by members via email, for the works to be carried out as soon as possible.

148/20 Highways:

a) To update on the CNA Highways Scheme submission for St Erme

There were no updates currently. The clerk had received an email regarding the speed of the traffic at Trispen Hill and the location of the 30mph signage. The clerk had responded to the resident informing them of the proposed scheme, which should address the location of the signage.

b) To update on the flooding at the bottom of Trispen Hill

There were no updates.

c) A30 Dualling update

We have been advised of a road closure during the day between 15th-17th March 2021 of the lane between Hendra and Carland Cross. This will enable Western Power Distribution (WPD) to connect the power feed to the Costain's compound at Carland Cross. The alternative route will be via Mitchell.

d) To update on the research of 'Interactive Speed 'signage for the Parish

There are no updates at this time once the current restrictions have been lifted, we will arrange a site meeting to look at the three possible locations.

e) To receive an email from a resident regarding the amount vehicles driving on the emergency access road through Killigrew Gardens.

The clerk has advised the member of the public on how to report her concerns to Cornwall Council and has provided information about the history of the emergency road. Members discussed if there are any possible solutions. The members felt that we have tried looking at solutions in the past, but with no success. It was agreed for members to think about this further and for the Clerk to speak to highways and the Police again regarding this issue. The item will be put back on the agenda of the next meeting.

149/20 To update on the St Erme Emergency Plan response to COVID 19 and support of the community.

We are continuing to help those that require support with collection of shopping/medication etc. where required.

The 'St Erme Community Larder' has had more families come forward for support. They are now supporting 43 families consisting of 69 Adults and 52 children which is a total of 121 individuals.

The Community Centre continue to offer a takeaway service on a Friday evening with deliveries or collection. They are providing free meals for children and young people up to the age of 19 in full time education in the community Monday's to Friday's. This consists of three hot meals a week, two packed lunches and cereal and milk for breakfasts. There are currently 22 children receiving this. This will continue until 8th March 2021 when the schools are due to reopen.

It was agreed that as some restrictions were still in place and with the forthcoming elections in May, that it would be best to put this on the agenda of the May meeting with a view to hold a public meeting in June (subject to government guidelines) to relaunch this and to form a Climate Action Group.

152/20 To update and consider the format of the Annual Parish meeting on Tuesday 16th March 2021

John Floyd from Census 2021 has accepted our invitation and is happy to give a 10-minute talk and answer questions. Jeff Mapps and David James from Costain have agreed to attend to give an update on the dualling of the A30.

The meeting has been advertised in the St Erme Parish Post due to be delivered the 1st week in March and will also be advertised on the council's website, Facebook page and parish noticeboards.
